**DOUBLE RIDING:**

Three hours of riding weekly are included in the camp tuition for all campers. Double Riding is instruction 6 days per week (rather than 3) for an additional fee. It's not recommended for boys due to their active tripping schedules. Double Riding sign-up is included in your Parent Pack sent in the spring.

**TO THE PARENT:**

A reservation fee of \$500, applicable towards tuition, must accompany this application. The tuition balance is due May 15 for all camp sessions.

**Early Bird Discount:** Application fees postmarked by November 1<sup>st</sup> receive a \$100 discount for the Main and Full Summer Sessions and \$50 for the June Session as well as an Early Bird gift for your camper. Introductory session campers, Junior & Mini sessions, are not eligible. **Family Discounts:** You may request \$100 off for the 2nd camper from the same household and family, 20% off the 3rd, 40% of the 4th or more... (Family Discount for Junior or Mini campers, is halved & counted last.) **FURTHERMORE: Large Family Discount:** If your immediate family has 4 or more dependant children, living at your home, whether coming to camp or not, you may request an additional 15% off your tuition charges for your first 2 campers and request the family discounts for your other children who come to camp. **Junior Counselor Discount,** for rising 11<sup>th</sup> and 12<sup>th</sup> graders, is 1/3 OFF the first year and 1/2 OFF the second year. Junior Counselors are not eligible to be included in other discounts. **Cancellations:** *If a request for cancellation is made prior to April 1st, the amount paid, minus \$100, will be refunded. After April 1st, the entire reservation fee is forfeited. As of tuition due date, no tuition refunds are granted for any reason, including medical. Trip insurance is readily available which covers lost camp fees and tuition in case of a medical difficulty. No reduction is made for campers arriving late or leaving early.* Make checks payable to CAMP KAHDALIA or CAMP CHOSATONGA.

**Unpaid Account Information &/or Legal Actions:** I agree that any legal actions by me for any reason will be in the exclusive jurisdiction of any court of the state of North Carolina located in the county of Transylvania and in the case of decisions in favor of said camp, I will be responsible for court costs, legal fees and out of pocket expenses of camp, its owners and employees. Furthermore, my account may be referred to an attorney or other agent for collection. If my account is collected in this manner, I agree to pay all costs of collection including reasonable attorney fees.

**Medical Issues:** I agree to provide medical insurance and have my child examined by a physician before camp, and I also acknowledge that I am responsible for any medical expenses incurred beyond the scope of the camp infirmary. I also give permission for routine medical care for my child by Camp Kahdalea's personnel. (A camp medical form is provided for each applicant and must be returned prior to arrival.)

**Release/consent/acknowledgment/assumption of risk:** I give permission to participate and understand that camp life, activities and trips have inherent risks including those of accidents, injury and even possibly death. Safety is a primary goal at camp. Counselors often have years of experience and usually go through a significant amount of training in First Aid, Wilderness First Aid, C.P.R., and/or activity skills, however I understand that they are fallible. I understand there are other inherent risks regarding camp and the activities including but not limited to the following: living in a woodland setting, a child not following directions, backpacking, hiking, caving, dance, gymnastics, high ropes course, mountain biking, horseback riding, white-water paddling, swimming, field sports, games, rock climbing, camp life, sleeping in primitive cabins or shelters, acts of nature, hail, lightning, bee stings, raccoon or bat or other animal contact and such animals could carry rabies, falling from bicycles, horses, rocks, rough trails and steps; as well as water related accidents or automobile accidents and more. In addition, the camp is not a lockdown facility, and cannot be responsible for a minor who wishes to run away or who leaves camp without permission. I further acknowledge that I will give, before camp, full disclosure of any preexisting physical or psychological conditions, challenges or problems which the child has. Any conditions must be accompanied by a doctor's statement regarding the camper's ability to participate.

**Hold Harmless & Indemnification:** To the extent allowed by law, I the undersigned waive, release, forever discharge and agree to indemnify and hold harmless David & Anne Trufant, Inc. dba Camp Kahdalea & Camp Chosatonga and/or its agents and/or employees and property owners from all rights and claims for damages, injury or loss to person or property which may be sustained or occur on or off the property during my child's stay with camp whether caused by negligence or otherwise.

My child and I understand that my child may be sent home for inappropriate behavior at the director's discretion with no tuition refunded.

I hereby give my permission to use my child's name and images and to publish them without debts or liabilities to me of any kind.
